Companies / Firms / Individuals interested to buy the aforesaid vehicle are required to submit their quotations in the enclosed proforma, addressed to 'Head of Chancery' Embassy of India, Thimphu either in person or by post latest by 5.00 p.m. of 03.05.2026. The quotations received will be opened by the Tender Committee at 03.00 p.m. on 04.05.2026. The vehicle is available for inspection from 10.00 a.m. to 4.00 p.m on all working days till 01.05.2026 at the address cited above. Embassy reserves the right to cancel or postpone the tender or reject any bid without assigning any reason.

3. Interested bidders may submit their bids, along with Earnest Money Deposit of Nu. 1,31,000/- (Ngultrum One Lakh Thirty One Thousand only) by the way of Demand Draft drawn in favour of ' Embassy of India, Thimphu'.

4. The tender cum auction will be governed by the following conditions:

(i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Nu.(1,31,000/-) within 7 days of acceptance of the bid by way of Demand Draft drawn in favour of 'Embassy of India, Thimphu'.

(ii) The delivery of the auctioned vehicle will be given only after the successful bidder makes the full payment and submits the documentary evidence in support of residential status (CID & Voter identity card in case of individual, and Registration Certificates in case of firms, etc.).

(iii) The auctioned vehicle shall have to be taken away by the successful bidder immediately at his own expense.

(iv) The auctioned vehicle will be disposed of on "as-is-where-is" basis and no guarantee for its worthiness or quality will be given by this Embassy.

- (v) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Embassy will not be responsible for any lapse on his part in this regard.
- (vi) The successful bidder shall not be allowed to withdraw his bid, failing which his earnest money will be forfeited.
- (vii) No request for inspection after submission of bid will be accepted.
- (viii) The entire set of documents should be submitted and no portion should be deleted/detached from the tender documents.
- (ix) Postal delays will not be accepted as an excuse for late submission of tender.
